




## WORKSHOP ON INTERNATIONAL FUNDING AND PARTNERSHIP

#### Introduction

The "Mattone Internazionale" project is sponsored by the Italian Ministry of Health and aims at increasing the role of the regional health systems and policies in Europe by strengthening their competences in investigating opportunities offered by the European Union and other international organizations ("bringing the health system and policies of the Italian regions in Europe and Europe in the health systems of the Italian regions").

The project foresees the implementation of information and training activities addressed to Ministry organizations, Italian Regions, local social-health authorities, hospitals as well as other stakeholders involved in health topics, in order to promote the dissemination of the main international donors and organizations' policies and opportunities to access their funding or collaboration programs in the framework of health, research and innovation in the national territory. The Italian Ministry of Health has delegated to the Tuscany Region the coordination of the component related to international health cooperation and health of migrants.

The health cooperation is considered one of the areas of greatest commitment of the international community for the achievement of the Millennium Goals. Over the past decade, the Italian regions have increased their commitment to development cooperation in general, and particularly in international health cooperation and global health acquiring a rich experience of organizational models, guidelines, methodologies and contents.

The awareness of the complexity and the growing importance of the regional commitment on these issues have led to the organization of several workshops since 2013 aimed at promoting the exchange of experience and information, to stimulate and strengthen the capacity of local networking and improve the efficiency and overall effectiveness of the interventions.

The training is organized with one plenary session on the 28 of September and training seminars for the days 29 and 30 with the participation limited only to the Italian Regions representatives.

#### **FIRST SESSION:**

### 28th of September 2015

Local authorities, their platforms and representative structures are increasingly being viewed as important and necessary actors in development policy. Local authorities can act as catalysts for change, conflict prevention, decentralisation and confidence-building in the development process - a fact recognized most recently in the European Consensus on Development and in the communication "Local Authorities in Development" – as well as in the increasing number of existing practices of regional and local authorities in the field of integration and cooperation with local and regional partners from third countries.

The workshop will address and debate subjects of interest for Italian Regions and the main civil societies organizations involved in development cooperation initiatives on the role of local authorities in development processes, the mechanisms inherent to them, and international programmes and support instruments and modalities.

It will entail the participation of representatives of:

- the European Commission (in particular DG Justice with a specific focus on REC Programme),
- the Joint Migration and Development Initiative (JMDI) programme, that is implemented by UNDP and focuses on the role and needs of local authorities to effectively link migration and development,
- the Italian Ministry of Foreign Affairs and Development Cooperation,
- the European platform of local and regional authorities for development (Platforma)
- the European Confederation of Relief and Development NGOs (Concord).
